### HPNJ EQUESTRIAN CAMPING AND TRAIL RIDING RULES AND REGULATIONS

- You must be a member of the Horse Park of New Jersey in order to participate.
   Memberships can be purchased at <a href="https://www.horseparkofnewjersey.com/Join">https://www.horseparkofnewjersey.com/Join</a>.
- By the State of New Jersey and the Horse Park of NJ, attendees are required to carry evidence of a negative Coggins test, current within twelve months.
- You may only use shavings to bed stalls.
- All shavings used in stalls must be removed and placed in the area designated.
- All stalls are to be cleaned and swept out before departure. For stalls not properly
  cleaned, the user will be charged a cleaning fee of \$35 per stall. A \$35 deposit will be
  collected upon registration and returned once we have verified the stall is clean.
- Horses must be in stalls with only one horse per stall.
- Dogs must ALWAYS be leashed.
- Lights, light fixtures and panel boxes are not to be altered or tampered with. Electrical outlets at the barns are for horse fans/clippers ONLY.
- Washing of vehicles and trailers is prohibited.
- Any wood or rock for chocking or leveling trailers or vehicles is to be removed prior to departure.
- No vehicles or trailers are to be parked on roadways OR between the Barns, as they also serve as FIRE LANES and AVENUES FOR EMERGENCY VEHICLES. Parking and camping must be in designated areas.
- No ATV's
- Horseback Riding is permitted in the adjacent Assunpink Wildlife Management Area. A
  PERMIT MUST BE OBTAINED from the NJ Department of Environmental Protection.

- All users are to stay on designated trails.
- Users are not permitted to jump any obstacles or jumps on HPNJ grounds.
- Users may not ride in the cross-country field other than to access Assunpink Wildlife
   Management Area.
- At least one on-site camper needs to be over the age of 18.
- Campers may only stay a maximum of 3 nights.
- Campfires are only permitted in designated fire pits and must be covered by a screen or grate.
- SMOKING IS PROHIBITED in all buildings to include stalls, barns and restrooms.
- The consumption or possession of an open container of alcohol is prohibited in all areas
- All visitors must make necessary arrangements to remove trash after their visit or event.
   Please remember to sort all recyclable materials when possible. Large events must independently contract for trash removal as part of their event coordination.
- A day is defined as arriving at 9 am or after and departing by 11 am the next day.
- NO REFUNDS WILL BE PROCESSED FOR NO-SHOWS.

It is mandatory to immediately report all injuries, accidents, and sensitive incidents to the Horse Park of New Jersey Management. 609-259-0170.

Daily fee \$20 per horse

Stall usage \$25 per day.

Stall Deposit \$35, to be collected upon registration and returned within 5 days after completion of the rental.

Camper hook-ups \$40 per camper space per day.

Further you voluntarily agree and warrant to Release and Holding Harmless the State of New Jersey, the Horse Park of NJ, , the Department of Environmental Protection, and any affiliates, agents, employees, or contractors from any liability, action, causes of action, losses, damages, debts, claims, incidents, and demands of any and every kind which may occur or you may suffer either during, after, or as a result of participation in the equestrian activity or as a result of the acts of omission, of any employee, agent, contractor or staff.
